IN THE ABSENCE OF ITS NEGLIGENCE, KAI SHALL NOT BE RESPONSIBLE FOR THE FAILURE OF ANY OF THE HOTELS, AIRLINES, RESTAURANTS, GROUND TRANSPORTATION COMPANIES, OR OTHER SUPPLIERS OF ARRANGEMENTS, SERVICES OR ACCOMMODATIONS TO PERFORM AS SET FORTH IN THE PROGRAM LITERATURE.
