# SHS BPA MEETING MINUTES | NOVEMBER 13 2018

CALL TO ORDER: Candice Vild called the meeting to order @6:44PM

**PRESENTATION OF MINUTES:** Minutes from the previous meeting were presented and approved

### **DIRECTOR'S REPORT:** Cheyne LaBonte

- Past, Present, & Future:
  - Our football team played a fantastic season. Sad to see it end, but we were proud to be a part of it.
  - The band directors are pleased with past band events (including MPA, Marching Festival, and the Veteran's Day concert). The kids have been working really hard and they finished marching season strong.
  - The Pride of the Tribe is officially the largest high school marching band the state of Florida, and we anticipate that we will remain in a building pattern for at least the next 2-3 years. We will have to monitor how this impacts the uniform inventory; it is not inconceivable that we may need to purchase additional uniforms to outfit all our musicians in coming years.
  - The football team recently lost one of their coaches. There has been a memorial fund set up in his honor; the BPA is looking into contributing to this fund.
  - Our flute section is planning on visiting local nursing homes over winter break. The Jazz Band visited Hamilton and Midway Elementary Schools today.
  - Tri-State report: 3 students qualified (Logan V, Sean V, and Payton). Kudo to these three students. Incidentally, Mr. LaBonte also participated in thi event as an SHS student; he gave thanks for the opportunity)
  - o All County Report: 6 students qualified (Nathan H, Bing G, Payton, Mei

and Nya L). Concert will be January 26 atWSHS.

#### TREASURER'S REPORT: Jill McAuley

Taxes have been filed; audit is nearing completion as well.

BPA account balance \$65,254.26 as of 10/31/18

Trip account balance \$204,499.40 as of 10/31/18

Students owe \$20,096.38 total outstanding unpaid dues

France trip: 135 total going (97 students, 36 chaperones, 2 band directors). Copies of passports of all students and chaperones who will be attending the trip need to be turned in to the trip committee; request has already gone out.

Jill submitted a check to the travel company today. Discussion was brought forward regarding the fact that the cost of the trip originally given to parents (and which the monthly payment installments was based on) was an estimate. Partly due to the fact that fuel prices have risen, but also due to other factors, the actual cost of the trip may actually be higher than was originally quoted per attendee. If the trip costs exceed what our students and parents have already committed to and paid in, the BPA may potentially allocate a portion of proceeds from the upcoming hosting of Solo & Ensemble MPA towards trip account.
