# SHS BPA MEETING MINUTES | AUGUST 4 2020

CALL TO ORDER: Gena Bukur called the meeting to order @6:05PM via Zoom

**PRESENTATION OF MINUTES:** Minutes from the previous meeting were approved and filed

**DIRECTOR'S REPORT:** PL Malcolm, Cheyne LaBonte (Past, Present, & Future)

- Recently some of the leadership students have been coming in to volunteer in
  the band room in small groups, to help organize the room. They've been working
  efficiently, and following all the safety guidelines. Big thank you to our
  leadership students, as well as to their parents for allowing them to come in to
  the school.
- Administration reports that of our 4300 total population of students at SHS, they have 1800 registered for Face to Face schooling mode starting in a few weeks. Results of the survey that the band directors published regarding school modality plans for the fall roughly match the metrics of what the administration published. 110 students replied to the survey the band directors published, of these: 60 students said they would be doing Face 2 Face, 45 said they would be doing Seminole Connect, 5 said they'd be doing hybrid. 89% of band students surveyed said that they would be interested in participating in a pep band experience this year. 87% stated that they would like to participate in some sort of modified halftime performance.
- If we will be continuing selling facemasks as a fundraiser, we need to have a final
  decision regarding if we will be expanding our offerings no later than next week.
- It's been decided that we should wait until school is underway before continuing the registration process. Band dues for this year will be: \$150 for new students (Fall), \$100 for returning students (Fall), and \$100 for both new & returning students in the Spring. Guard dues TBD.

#### TREASURER'S REPORT: Jill McAuley, Mihaela LaFleur, Molly Bell

We have sold 225 masks to date. Discussion regarding the continuation of mask sales will be continued in the What's App group for this committee. Directors request that an additional line item be added to the budget this year, to cover potential unexpected expenses due to the pandemic (perhaps a discretionary technology line). For example, the band directors requested the purchase of the following items: a mount/stand of some sort for an ipad or a laptop, so the device can be angled with the camera towards the board, so the directors can teach F2F and SC simultaneously.
